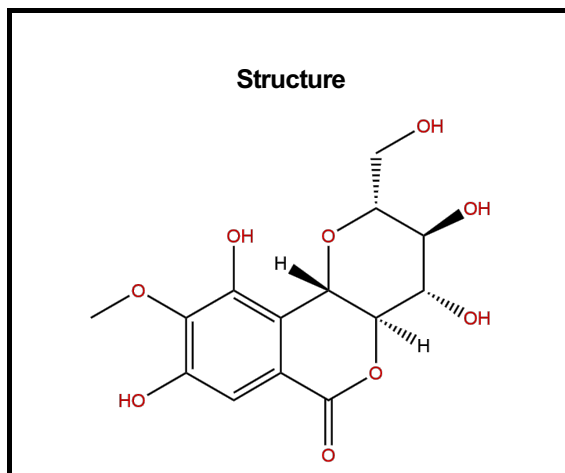

Rate: 1.0ml/min; Sample dissolution: 20% Methanol in water; Mobile Phase: A, 0.1% Phosphoric acid in water B, Acetonitrile; Gradient elution: B, 5%-15%, 15min.

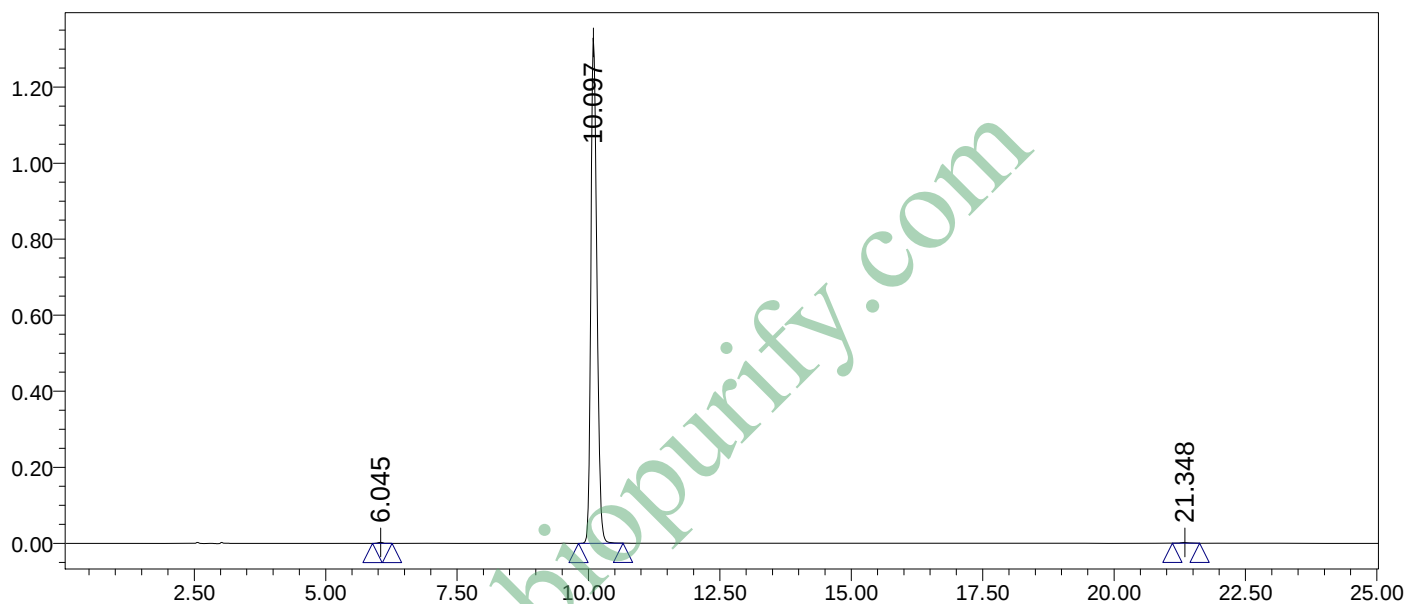
